While Oracle NetSuite provided a solid ERP foundation, the rollout from the parent company was designed primarily for trading operations, not for a manufacturing environment like THE STUDIO – BKK's.

This led to several local challenges, including:

- Accounting and tax processes that did not fully comply with Thai Revenue Department requirements.
- Limited functionality for manufacturing-specific needs such as raw material management and cost control.
- A reliance on manual work and Excel spreadsheets for reconciliations and reporting, which increased both workload and risk of error
